OUR PROGRAMS

DOMESTIC ADOPTION

Our Domestic Adoption Program provides comprehensive services and support for adoptive and birth families throughout New York and New Jersey.

INTERNATIONAL ADOPTION

Through our Hague-Accredited International Adoption Program, Spence-Chapin finds loving families for children from South Africa, Bulgaria, and Colombia.

SPECIAL NEEDS ADOPTION

This unique program connects children who have medical and developmental challenges to adoptive families who are able to care for their long-term needs.

INTERIM CARE

This vital service offers 24-hour care for newborns in the home of a volunteer family while birth parents work with a Spence-Chapin counselor on a plan for the future.

GRANNY PROGRAM

Spence-Chapin pairs children living in group homes and pediatric care facilities with caregiver "Grannies" who offer consistent one-on-one play and attention to help each child thrive.

COUNSELING & COMMUNITY

Spence-Chapin's team of experienced clinicians and social workers offer lifetime support, counseling, and community to birth and adoptive families.

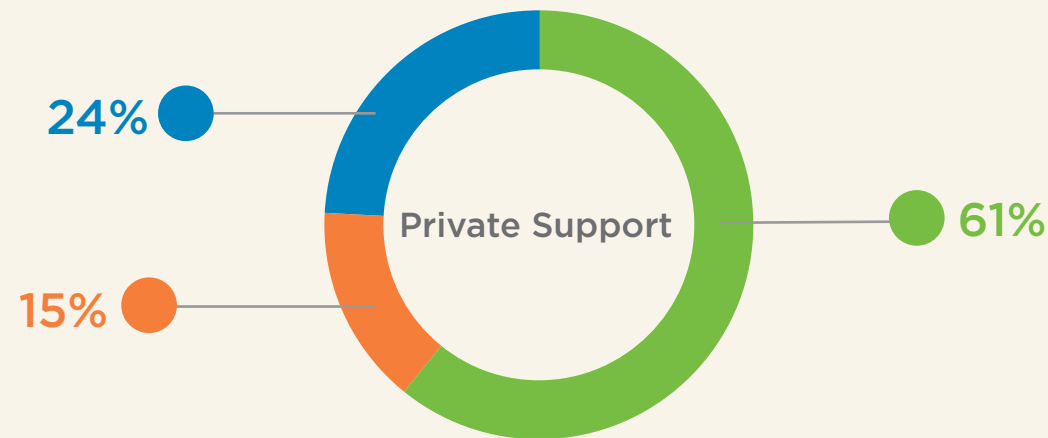

MEET BABY LILY



Lily was born in October 2017 and diagnosed with Prader-Willi Syndrome, a rare and incurable genetic disorder that affects cognitive function, appetite, and growth. The diagnosis came as a surprise to Lily's parents, who had recently arrived in the United States

from China. Concerned they would not be able to manage Lily's specific medical needs, they called Spence-Chapin who met with them at the hospital that same day.

Over the course of several weeks, Lily's birth parents worked with a Spence-Chapin social worker who provided information, counseling, and support to help them decide on a permanent plan for Lily. During this time, Lily was cared for in the home of a volunteer family from Spence-Chapin's Interim Care Program. Lily's birth parents were able to visit their daughter, receive updates on her progress, and discuss the results of the many medical appointments and evaluations coordinated by Spence-Chapin while Lily was in Interim Care.

After exploring their options, Lily's birth parents decided that adoption was the best choice for her. They believed that her needs would be best met by a family prepared and equipped to deal with all the challenges that awaited her. Spence-Chapin helped them explore and articulate the characteristics they hoped for in an adoptive family for Lily.

After being presented with several potential adoptive families, Lily's birth parents chose a couple who were currently parenting a child of Chinese heritage who also had Prader-Willi Syndrome. Spence-Chapin worked with the birth parents to create a plan for continued future communication and contact with Lily and her adoptive family.

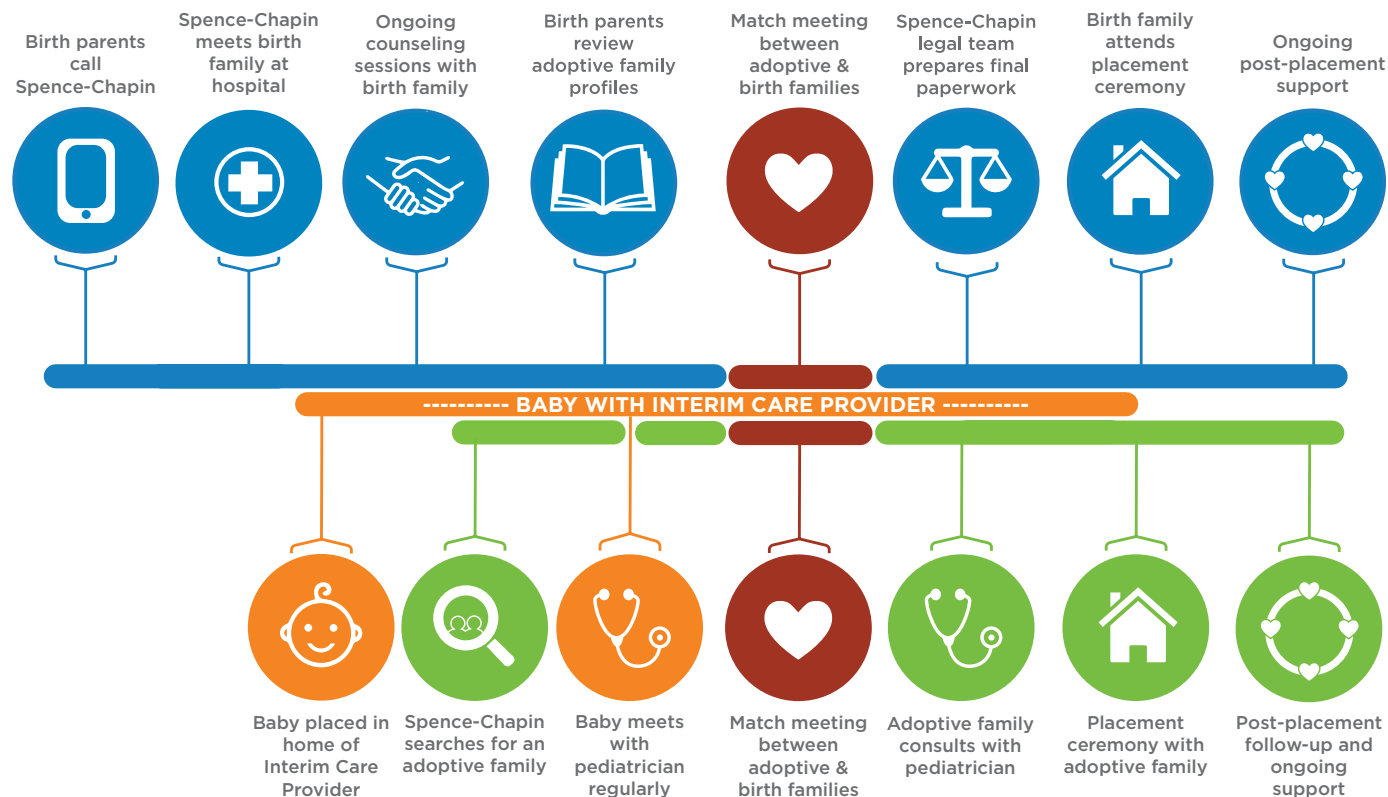
