



A Granny's Love

When Jordan's Granny first met him, she realized that Jordan was two years old but completely non-communicative. This isn't surprising—due to limited resources, many orphanages around the world are understaffed and unable to provide children with one-on-one attention and care, with detrimental effects on their development. For every three months spent in institutionalized care, a child will lose one month of linear growth in the absence of proper intervention.

The Granny Program provides this intervention by bringing loving caregivers, or "Grannies" from the local community to each child, every day.

Jordan's Granny, like all Grannies that work with Spence-Chapin, has been thoroughly trained on child development and trauma-informed care, so she knew not to push. Instead, every day for the first week, she would come in, join him, and they would silently play. They'd stack blocks, play with a ball, color his paper, though he had difficulties grasping and properly using his crayons. At the beginning of the second week, she noticed a change. Jordan was looking her in the eye and pointing at the games that he wanted to play with her. He was indicating which ones he enjoyed, and which ones he didn't like as much.

"He was communicating with me!" said his Granny, beaming.

It was a wonderful start. Since then, Jordan has become much more communicative with his Granny, the staff, and other children in the orphanage. All sorts of developmental skills have been improving, and he's learning to write. He hugs his Granny and loves to see her come in, excited to learn and play with someone that cares deeply for him. The bond the two of them have formed is a testament to the success of the Granny Program and is one that is present between each of the 148 children who currently benefit from the program, and their dedicated Grannies.

As Granny Sosa explains, "These kids need love. They don't have parents, so I'm here for them, to give them love, to show them how important they are.

Our Year In Review









GRANNY PROGRAM GROWS IMPACT The Granny Program and Project Play have continued to expand throughout Johannesburg, South Africa, supporting more than 148 children throughout four orphanages. Spence-Chapin also completed two more playgrounds, so that all four homes now have a dedicated Spence-Chapin was also able to respond to requests for food and essential supplies to children at No More Victims, a shelter for children who have been victims of abuse and neglect, and Masibambisane, a center that supports children in the underserved community of Eldorado Park in Johannesburg.

VIRTUAL EVENTS HIGHLIGHT KEY PROGRAM
