

# AMY, JA, AND THANDI



Amy always knew she wanted to be a mom. When she decided to start her journey to parenthood, she explored different options and ultimately decided that adoption was the right pathway for her. She was drawn to Spence-Chapin for their values, track record, and their Granny Program.

"I worked with orphanages while in the Peace Corps, and later through various humanitarian aid organizations, so I knew enough to know that the caregiver-to-child ratios are way out of whack, which is detrimental to a child's development. The Granny Program just seemed really great."

Amy was matched with her daughter on March 31<sup>st</sup> 2021. When Amy saw the photo of the little three-year old with her big, bright smile, she just knew, this was her child.

"I guess you could say she had me at her smile."

Nonjabulo, nicknamed "Ja," had been paired with her Granny, Gogo Thandi, when she entered Princess Alice Children's Home in South Africa at 3 months old.

"The feeling of knowing that there was someone in Nonjabulo's life that was with her every day, spent many hours a day with her, taught her all of the first things she learned to do...that's incredibly special...Without that experience, there's no telling where she would be today," said Amy.

During their first Zoom call, Gogo Thandi was present and shared valuable insights about Nonjabulo's development. When Amy traveled to South Africa to bring her daughter home, she met Gogo Thandi in person, and was able to express her gratitude for the love and care she gave Nonjabulo.

Since coming home, Amy and Ja have had many adventures together. "What had been important over this last year," Amy explains, "is providing Nonjabulo little pieces of continuity from the life she had before." They've traveled around the United States visiting children who Ja knew in South Africa and their new families. And all along the way, they've kept Gogo Thandi up to date, sending photos and emails.

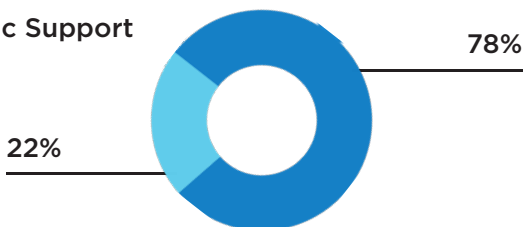
Gogo Thandi admits that it was hard to say goodbye to Ja. "It's very sad, very tough. But you know that you have to, because they need love. They need to have a better education, to experience the world. Because when they have parents, they can explore and see everything."

And Amy and Ja certainly have. "Having her is my biggest reward," Amy says.
