Post-Placement/Post-Adoption Reporting/Visits	If you are granted a provisional adoption order in Antigua & Barbuda, 12 months of supervision will be required, necessitating at least quarterly post-placement visits/reports. More visits/reports may be required based on your state of residence. In cases where a family receives a final adoption order, one post-adoption visit will be required. Each visit is at a fee of \$450. Upon approval of 1600, families will pay for the number of post-placement visits required based on the facts of their case.	\$450 per visit	Spence-Chapin

¹ The stated fee of \$3,000 is for families adopting a single child. For families adopting more than one child, an additional \$815 will be due per child beyond one child because in cases in which a family adopts multiple children, Spence-Chapin must render \$815 per additional child beyond one child to CEAS.

If you are given a provisional order and, if you live in New Jersey, New Jersey requires a minimum of 4 visits within 6 months (the first of which must be within 14 days of homecoming) then quarterly until finalization for children under 5 years. For children 5 years and older New Jersey requires a minimum of 6 visits within 6 months (the first of which must be within 14 days of homecoming) then bimonthly until finalization.

³ This range reflects the filing fee plus biometrics for a single applicant or for a couple. Please note that if for each additional adult member of the household, a biometrics fee of \$85 is charged by USCIS; additionally if you file the I600 for multiple children who are not biological siblings, an additional \$775 per child after the first child is charged by USCIS.
